Current Toxins of Interest in Pediatrics – Sophie Gosselin

- Differentiate the kinetics of inhaled versus ingested cannabis products

- Recognize the difficulty with ingestions of liquids with unlisted ingredients potentially containing glycol ethers or toxic alcohols.
