Focus on The Evidence behind the Medicine

Alternatives to Imaging in the Management of Head Trauma in the Elderly: The Falls Clinical Decision Rule - Justine Lessard

- Learn the pitfalls of existing clinical decision rules regarding mTBI
- Apply new clinical decision rules to forego the need for CT for a fall in the elderly population
- Discuss the indication for a transfer to a neurotraumatology centre with positive findings on head CT within the mTBI population

- Understand why an opioid-centric approach to managing acute opioid withdrawal in the emergency department is best
- Identify the risks and benefits associated with methadone and buprenorphine/naloxone in order to best treat emergency patients with opioid use disorder

- Familiarize yourself with literature guiding these concepts
- Integrate the material by analyzing and solving different cases

- Identify the patients that would benefit from a palliative care intervention in the ED
- Plan trajectory for patients based on goals of care assessment in the ED
- Discuss evidence-based treatment options for common symptoms related to end-of-life care

Practical Tips on How to Teach Effectively in the ED – Anali Maneshi / Humaid Alkhateri

- Effectively assess learners' baseline knowledge and experience at the beginning of the shift to customize the teaching depth and complexity.
- Prioritize and emphasize key teaching points to improve learner retention and understanding without causing cognitive overload.
- Coach learners in an emergency medicine-specific approach to seeing patients, focusing on critical time management skills.
- Discuss strategies in delivering constructive feedback at the end of the shift to reinforce learning, address gaps, and complete the teaching process.
